
4th Quarter Summary for Fiscal Year 2023/24

Pumping Plant

- Contract awarded in September 2020
 - Completed crane installation at Intake
 - Notices of completion filed in June 2024
- Total Project Estimate: \$19.7 M
- Total Project Cost thru Jun: \$19.0 M

Allen-McColloch Pipeline PCCP Urgent Rehabilitation – Stages 1 & 2

- Change Order Authority for Stage 1
 Authorized in February 2024
 - All relining upstream of OC-88 completed
 - Pipeline returned to service from Diemer to OC-88
- Contract for Stage 2 awarded in May 2024
- Total Project Estimate: \$67.0 M
- Total Project Cost thru Jun: \$13.6 M
