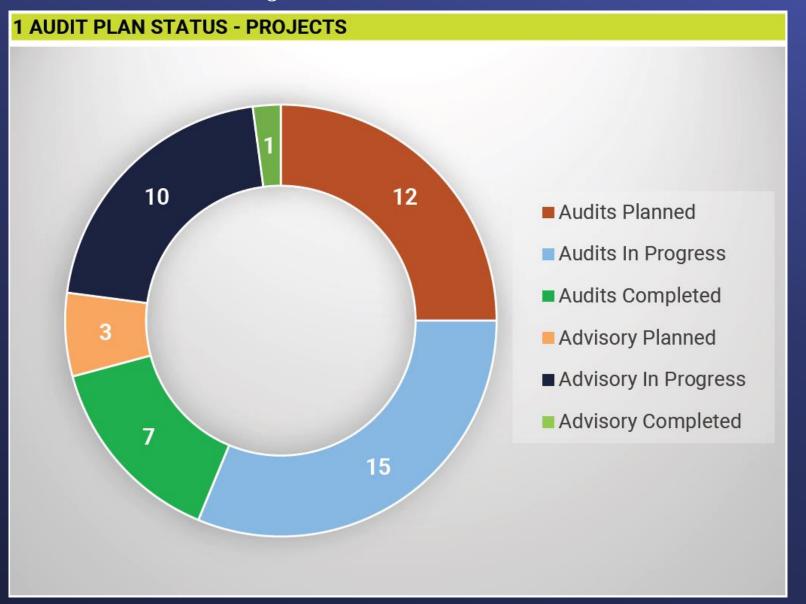

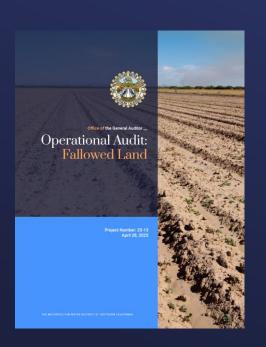

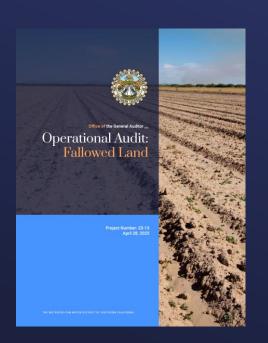


l. Operational Audit: Fallowed Land

Background (Board Requested Audit)

- Metropolitan entered into agreements with PVID and 99 landowners to fallow qualified farmlands through July 2040
- Metropolitan reimburses tenants the prorated rent of up to the agreed-upon rate per irrigated acre and a water toll per irrigated acre
- Tenant reimbursements were approximately \$2.6 million for contract year 23/24
- The total amount of water conserved by the fallowed land program was 87,256 acre-feet in 2023

Objectives & Conclusions

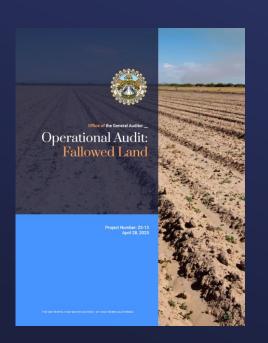
(l) Evaluate Water Resource Management monitoring procedures for the fallowed land process, from fallowing call notification to inspection of fallowed land.

Some monitoring procedures should be improved.

(2) Determine if defined fallowed land acreage matches actual fallowed land acreage on the ground.

Defined fallowed land acreage matched actual fallowed land acreage on the ground.

l. Operational Audit: Fallowed Land (con't)

Recommendations

- (I) PVID fallowed land inspections: WRM conduct reviews, document reviews, develop associated procedures
- (2) WRM fallowed land reports: management review prepared reports, document reviews, prepare associated procedures
- (3) Fallowed land call notices: GM approve before issuance, prepare associated procedures
