Current Conservation Program Activity FYs 2024/25 & 2025/26



Turf Replacement Rebates:

November: 270,366 ft² replaced

FY2024/25-FY2025/26: 7,904,208 ft² replaced



Trees (part of Turf Replacement Program):

November: 124 trees rebated

FY2024/25-FY2025/26: 2,833 units rebated



Smart Controllers:

November: 403 units rebated

FY2024/25-FY2025/26: 8,055 units rebated

Lifetime Water Savings to be achieved by all rebates in November 2025: 2,819 AF

FY2024/25-FY2025/26: 63,001 AF lifetime water savings

Commercial & Public Agency Turf Replacement Grant Funding

July 2024 Implementation of \$30M DWR grant awarded to provide additional \$1 per square foot (sf) for CII and Public Agency turf replacement incentives



Update on DWR Turf Replacement Grant Funding

\$30M DWR UCDR Grant for CII and Public Agency Turf Replacement *Totals as of January 5th, 2026*

Funding Spent (Projects Completed)	Funding Committed* (pre-approved projects)	Funding Requested** (new applications not yet pre-approved)	Total
\$3M	\$7.6M	\$24.3M	~\$35M

* Some committed funding may be released back into the program if:

- A pre-approved application is cancelled
- The customer does not complete their project in time
- The customer fails to complete their project in accordance with the terms and conditions of the program

** Not all applications requesting DWR funding will be committed:

- Non-qualifying sites
- Non-responsive customers to application issues,
- The program reaches its committed grant funding threshold (\$30M)

Update on DWR Turf Replacement Grant Funding (continued)

- Staff anticipates the program will reach committed dollar threshold within weeks
 - Messaging scaled back to refrain from advertising the \$7/sf rebate
- CII and Public Agency Turf Replacement incentive for will revert to \$4/sf once all DWR funding has been committed or March 1, 2026 (whichever is sooner)
- Additional language added to SoCalWater\$mart website to clarify funding not guaranteed until a formal pre-approval has been issued
- Member and Retail Agency staff notified of increased grant activity and Metropolitan's outreach strategy

Update on Residential & Large Landscape Survey Program

Update on Residential and Large Landscape Survey Program

- Current three-year agreement with WaterWise Consulting for large landscape and residential surveys through 2028
 - Total not-to-exceed \$600,000
- Increase in residential survey activity
 - Member and retail agencies use program as a qualifier for low-income leak repair programs
- Large landscape survey activity increases
 - AB 1572 (2023) outreach & increased TRP rebate
 - Participants use survey as first step to determine non-functional turf areas and ROI for turf replacement
- Staff to request Board action in Spring
 - Additional funding to prevent lapse in program services
 - Addition of CII indoor survey, to include LA28 venues
