54136 The Board of Directors of The Metropolitan Water District of Southern California met on Tuesday, August 19, 2025.

Chair Ortega called the teleconference meeting to order at 2:45 p.m.

Chair Ortega addressed the following: Other Matters and Reports.

54140 Chair Ortega asked if there were any corrections to the report of events attended by Directors at Metropolitan's expense during the month of July, as previously posted and distributed to the Board. None were made.

54141 Chair Ortega referred to the Chair's monthly report, which was previously posted and distributed to the Board. In addition, he announced August is National Water Quality Month, and Metropolitan is marking the occasion on social media with a series of short videos

featuring employees and collaboration with social media influencer Evan Lovett of Los Angeles.

54143 General Counsel Scully, in addition to her written report, referred to the Patz v. City of San Diego case, noting the Court of Appeals of the Fourth District released its opinion, upholding the challenge.

54151 Award a \$1,454,000 construction contract to MMC Inc. to replace the San Jacinto Diversion Structure slide gates, as set forth in Agenda Item 7-3 board letter.

54152 Award a \$370,900 construction contract to American Wrecking Inc. for the removal of three existing gate frames in support of the San Gabriel Tower Improvements, as set forth in Agenda Item 7-4 board letter.

54153 Review and consider the California Public Utilities Commission Final Subsequent Environmental Impact Report, adopt the Commission's findings, and authorize the General Manager to grant a permanent easement to Southern California Edison for overhead electrical transmission purposes on Metropolitan fee-owned property in the County of Riverside and identified as Assessor Parcel Number 189-110-011 and 189-120-005, as set forth in Agenda Item 7-5 board letter.

54154 Authorize the General Manager to convert seventeen Operations and Maintenance Assistant positions at the Gene Pumping Plant from recurrent to regular part-time status with corresponding Position Control Numbers and Human Resources to take all necessary actions to implement the conversion, including negotiating any required language with the unions, as set forth in Agenda Item 7-6 board letter.

54155 Authorize the Local Supply Exchange Framework; delegate authority to the General Manager to enter into agreements to facilitate the exchange; and amend the Metropolitan Administrative Code to facilitate exchanges. The General Manager shall provide a written assessment of exchange agreements involving supplies receiving Local Resources Program funding and provide a written status report following the first 100,000 acre-feet of exchange activity facilitated by Metropolitan in addition to periodic updates, as set forth in Agenda Item 8-3 board letter.

54156 Authorize the General Manager to enter into a new three-year sole source agreement with WaterWise Consulting Inc. for inspection and verification services for Metropolitan's Conservation Programs, for a total agreement not to exceed \$4,500,000; by the end of the third year, the General Manager is directed to conduct a competitive process for the services provided by this agreement, as set forth in Agenda Item 8-4 board letter.

Director Erdman moved, seconded by Director Sutley, that the Board approve the Board Items 6A, 6B, 7-2 through 7-6 and 8-3 through 8-4.
