The proposed framework allows Metropolitan to facilitate the exchange of local supply among its member agencies


Next Steps

Background

- Metropolitan has long recognized the importance of local supplies
- Through LRP, Metropolitan has supported local agencies in developing local supply projects
- Received feedback that member agencies have additional local supply production capability, and other member agencies interested in purchasing local supply

Timeline




Start of Business Model Refinement Process

June 2024



Ad Hoc Working Group provided status report and recommendations

April 2025



Board commissioned Ad Hoc Working Group





Staff participated in a series of targeted sub-working group workshops



Considerations identified by sub-working group

Policy changes needed to support local supply exchanges	
Seller must consume the local supply being exchanged	
Metropolitan should only deliver to participating agencies when Metropolitan supplies are available	
Exchanges should not result in an additional cost to the region	
Available capacity in the system	

Unintended consequences identified by sub-working group

Financial Sustainability Exchanges may lower demands and impact future Metropolitan sales
Operational Flexibility Additional demands on Metropolitan's regional supply
Potential impacts to blends
WSAP Implementation Counteract purpose of WSAP
Regional Reliability Create future obligations for Metropolitan
Other
Unforeseen unintended consequences


How could Metropolitan facilitate the exchange?



Seller produces and consumes local supply within its service area

Metropolitan delivers imported water equivalent to local supply amount to Buyer's connection

How could the water and money flow?



Buyer coordinates amount and payment with Seller, which does not involve Metropolitan.

What's being exchanged between seller and buyer?



Seller

- Receives payment from Buyer for local supply sold, but being produced and consumed in the Seller's service area
- Exchanges the delivery of Metropolitan water to their service area for delivery of Metropolitan water to the Buyer's service area
- Receives a bill from Metropolitan for exchanged deliveries (accounted as a Metropolitan purchase)

Buyer

- Receives delivery of the Metropolitan supply
- Receives benefits of local supply

Potential Framework Terms



- Proposals would be brought to Board for approval
 - Metropolitan would enter into an agreement with Seller for the exchange
- Demand on Metropolitan will not increase as a result of exchange
 - Negotiated between the Seller and the Buyer
 - Reconciliation and certification of exchanged water on an annual basis
- Exchange is not guaranteed and is subject to Metropolitan's discretion
- Amount of Metropolitan water delivered is concurrent with local supplies being consumed by the Seller
- Local supplies will not be introduced into Metropolitan's system and no wheeling will be taking place
- Metropolitan will receive the full-service rate for any Metropolitan supplies delivered

What policy changes are needed?



Metropolitan's Administrative Code

 Amend MWD Administrative Code Sections 4205 and 4501 to accommodate procedures under Framework including facilitating the delivery of supplies to an alternative connection while billing the Seller What happens during a WSAP allocation?



The credit and benefit of the local supply production are accounted to the Buyer



The exchanged supplies are accounted to the Seller as Metropolitan purchases (counts against Seller's allocation)



Metropolitan would enforce any penalties applicable at the time of the restriction for any parties that exceed their allocated Metropolitan supplies in the WSAP

Local Supply Exchange Framework addresses considerations

Ø	Policy changes needed to support local supply exchanges	Amend MWD's Administrative Code Sections 4205 and 4501 to facilitate deliveries to alternative connection while appropriately billing Seller.
	Seller must consume the local supply being exchanged	Local supply produced and consumed by Seller must be documented to ensure exchange is balanced.
Ø	Metropolitan should only deliver to participating agencies when Metropolitan supplies are available	Exchange subject to Metropolitan's discretion based on available supplies and operational feasibility
₫	Exchanges should not result in an additional cost to the region	Metropolitan will receive full-service rate for all supplies delivered.
₫	Available capacity in the system	Deliveries of exchange is not guaranteed and made only when operationally feasible for Metropolitan

Local Supply Exchange Framework addresses unintended consequences

Ø	Financial Sustainability Exchanges may lower demands and impact future Metropolitan sales	Facilitation of regional local supply exchanges will increase total production in the service area.
V	Operational Flexibility Additional demands on Metropolitan's regional supply Potential impacts to blends	Metropolitan would only facilitate exchanges when operationally feasible and supplies are available. Metropolitan would maintain the blending goals of the Colorado River and State Water Project supplies.
	WSAP Implementation Counteract purpose of WSAP	Water delivered will be documented and accounted to appropriate agency. Local supply benefit will go to Buyer.
Ø	Regional Reliability Create future obligations for Metropolitan	Exchanges would be concurrent with local supply consumption.
	Other Unforeseen unintended consequences	Framework allows for ability to make future refinements to the policy.



Increases total local supply production in the region and facilitates agreements between member agencies to exchange the local supply in the region
