


### WSDM Update

SWP Table A
Allocation
Increases to
30%

- SWP Table A Allocation increased from 5% to 30%
  - Improved hydrologic conditions from late December and January storm events
  - Observed and projected storage level increases at Lake Oroville
- Additional increases to the SWP Table A Allocation expected
  - February allocation study will begin to incorporate forecasted runoff from snowpack
- At a 30% SWP Allocation DWR is no longer allocating Human Health & Safety (HH&S) supplies
  - Metropolitan will not accrue HH&S payback obligations for 2023

## Northern Sierra Snowpack Above Normal As of 02/10/2023




### Northern Sierra Precipitation: 8-Station Index

As of 02/12/2023





### Significant Gains in Lake Oroville Storage

# Above Normal Snowpack for Upper Colorado River Basin As of 02/12/2023








2023 SWP Dependent Area Monthly Demands on Metropolitan

### EWCP Update

2023 EWCP Volumetric Limits Adjustments

- 2023 volumetric limits adjusted as a result of the net increase in the supplies available to Metropolitan
  - SWP Dependent Area notified of two adjustments on January II and January 31, 2023
  - Updated volumetric limits in effect February through June 2023
- Recommendation for Board action in March 2023:
  - Rescind the EWCP volumetric limits and mandatory requirements
  - Retain General Manager's emergency authorities
- Staff continue to evaluate and respond to the improving SWP hydrologic conditions

- Ongoing WSAP coordination with member agencies
  - Gaining an understanding of the WSAP
  - Discussions on considerations for the potential WSAP implementation
  - Next WSAP coordination meeting: February 28
- Considerations for a WSAP
  - Limited Colorado River Aqueduct diversions for 2023
  - Availability of State Water Project Table A Allocation for Blended Area needs
  - Demands in the SWP Dependent Area and storage management for future reliability
- Conservation continues to be important tool in helping region manage unpredictable supply conditions
