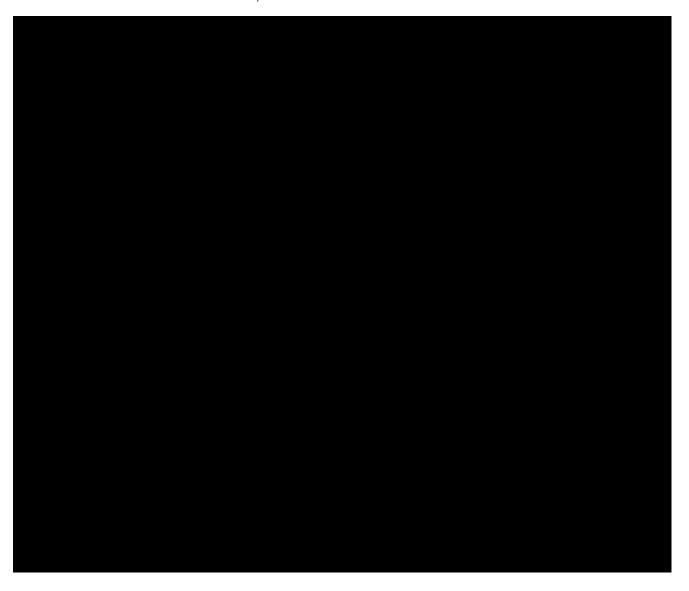




Any adverse action by the Board against Mr. Hagekhalil will not withstand legal scrutiny. Not when one director has admittedly made, and another is being investigated for making, overtly Anti-Arab and Islamophobic statements about Mr. Hagekhalil and

others of Arab descent, including Mr. Hagekhalil's Chief of Staff.³ That these directors have been or will be involved in decisions about Mr. Hagekhalil's employment—from precipitously placing him on "temporary" administrative leave to whether he will continue to serve the District—is not only wrong, but it is also powerful evidence of racial and ethnic discrimination, which of course is unlawful.



³ A Board member was found to have used the term "camel jockey" to refer to Mr. Hagekhalil's Chief of Staff. Multiple witnessed heard another Board member, also under investigation, saying "When are we going to get rid of those refugees?" and "When are we going to hire someone that we can pronounce their last name?"—referring to Mr. Hagekhalil and/or his Chief of Staff.



While the Board hired Mr. Hagekhalil to reform this agency, each time he took appropriate action to that end, he was subjected to baseless complaints. This occurred when 1) he took action in response to the Shaw Law Group report, 2) he brought in new leadership in Human Resources, 3) he hired a chief of staff from outside the agency, 4) he told Ms. Kasaine that he was considering changing her job responsibilities, and told the same to the General Counsel, and 5) when he disagreed with the Assistant General Counsel in a closed session board committee meeting.

Each time, he was subjected to a full EEO investigation, approved by the Board, or an ethics investigation. Clearly, Mr. Hagekhalil has been treated very differently than his predecessor (a white male), whose workplace behavior was openly tolerated by the Board.

In short, there is no basis to take adverse action against Mr. Hagekhalil. To do so would expose the District and the Board to significant legal liability, not to mention catastrophic reputational and other fallout. The only path to avoid this risk and at the same time restore Mr. Hagekhalil's reputation, which has been so regrettably tarnished, is to reinstate him so that, in partnership with the Board, he can lead the District and continue its important work, especially during this critical time.
