

Highlights

Metropolitan's Press Office worked with the San Diego County Water Authority to organize a media event at the Water Authority's headquarters announcing and signing the settlement agreement between the two agencies. A joint press release was issued. The event was well-attended by media and livestreamed, with interviews regarding the settlement with Chair Ortega and GM Upadhyay and Voice of San Diego, San Diego Union-Tribune, and KPBS. (June 2)





Metropolitan collaborated with member agencies and the State Water Contractors to advocate for Gov. Newsom's legislative proposal to streamline administrative processes for the Delta Conveyance Project. Directors, member agencies, and staff participated in a Sacramento advocacy day on June 11, visiting Southern California representatives to share information about the State Water Project and seek support for the Governor's proposal. By the end of June, 31 legislators had signed on to a support letter and a dozen more legislators have expressed their support. In addition, 127 business, labor, community organizations, and water agencies had signed on to a coalition letter.

Legislative Services

Federal

Congress continues to work on a budget reconciliation bill that contains \$500M for "construction and associated activities to restore or increase the capacity of existing Reclamation conveyance facilities." The FY26 appropriations process started with budget hearings in both chambers where lawmakers indicated they will provide more funding for water programs than is included in the President's budget.

State

AB 580 (Wallis) to extend Metropolitan's alternate authority under the Surface Mining and Reclamation Act moved to the Senate Natural Resources and Water Committee.

Metropolitan staff worked to advance the following bills: AB 259 (Rubio) eliminating the sunset provision in the Brown Act for teleconferencing; AB 532 (Ransom) for local water agencies to establish low-income rate assistance programs; SB 31 (McNerney) increasing the use of recycled water in non-potable applications; SB 72 (Caballero) to improve future planning of California water supplies; SB 394 (Allen) increasing penalties for fire hydrant water theft; and SB 454 (McNerney) establishing a PFAS Mitigation Fund to address PFAS contamination in California's drinking water and wastewater systems. Metropolitan maintains an oppose unless amended position on AB 794 (Gabriel) which would allow for an emergency regulatory process for the State Water Board's PFAS regulations on drinking water standards; this bill was moved to the Assembly Inactive File. Metropolitan also maintains an oppose unless amended on AB 1319 (Schultz) which would amend the California Endangered Species Act to authorize the California Fish and Game Commission to adopt an emergency regulation that adds a federally listed species that is native to California to the list of endangered or threatened species on an emergency basis under certain conditions. Metropolitan maintains an oppose position on AB 1146 (Papan) which would authorize the State Water Resources Control Board to issue an interim relief order to prohibit release of stored water if the release is done under false pretenses, and on SB 601 (Allen) increasing the State Water Board authority to regulate wastewater discharges. Staff is working with the bills' authors to address concerns.


For Father's Day highlighted three Metropolitan dads and their kids as they volunteered their time to educate the community about Southern California's water resources.


