Rehabilitation and improvement of a chemical feed facility at the Diemer plant to enhance reliability and worker safety


Recommendation and Fiscal Impact

Award a construction contract to rehabilitate and improve a chemical feed facility at the Diemer plant

Background

- Chemicals are utilized in the water treatment processes
- Due to the corrosive nature of the process, periodic replacement of chemical feed systems is required
- Upgrades to the coagulant, liquid polymer, dry polymer, ammonia, fluorosilicic acid (FSA) are planned
 - Beginning with the FSA feed facility & multipurpose chemical feed facility



Diemer Plant

Background – Existing Facilities

- Central Chemical Feed Facility
 - 1963: Originally constructed as a chlorine unloading facility
 - 2003: Converted to a temporary sulfuric acid facility
 - 2008: Converted to an FSA storage facility
 - Inadequate roof clearances prevent inspection & proper maintenance
- Dry Polymer Feed Facility
 - 1991: Facility constructed adjacent to Central Chemical Feed Facility
- Both facilities Tanks & equipment have exceeded life expectancy & require replacement




Existing Facility




Tank Farm Roof Clearance

New Chemical Feed Facilities

- Improved reliability of the chemical feed facilities with new feed system & storage tanks
- Multipurpose feed facility minimizes service interruption during construction & future planned upgrades
- Improved operational flexibility
 - New roof with access hatches
 - Enhanced chemical dosing accuracy
- Added enhanced safety features
 - Control panels relocated
 - Safety platform & fall protection for elevated work
 - Safety eyewash & shower

Alternatives Considered

- Considered Alternative Install a liner for the storage tanks
 - Significant structural & tank modifications required
- Considered Alternative Staging with tank replacements first, defer safety/maintenance improvements to later
 - Significant feed equipment and roof removal required due to limited accessibility
- Selected Alternative Complete replacement of the storage tanks, roof and feed system
 - Maintains plant reliability
 - Enhances worker safety, meets latest chemical safety standards

Diemer Chemical Feed Facility Improvements

Scope of Work

- Contractor
 - Replace chemical storage tanks
 - Replace chemical feed equipment & piping
 - Relocation of controls & instrumentation
 - Replace roof structure
 - Conversion of dry polymer tank farm into a multipurpose feed facility
 - Addition of safety features
 - Hazardous material removal & abatement
- Metropolitan
 - Multiple shutdown coordination
 - SCADA integration
 - Equipment testing
 - Project management
 - Inspection
