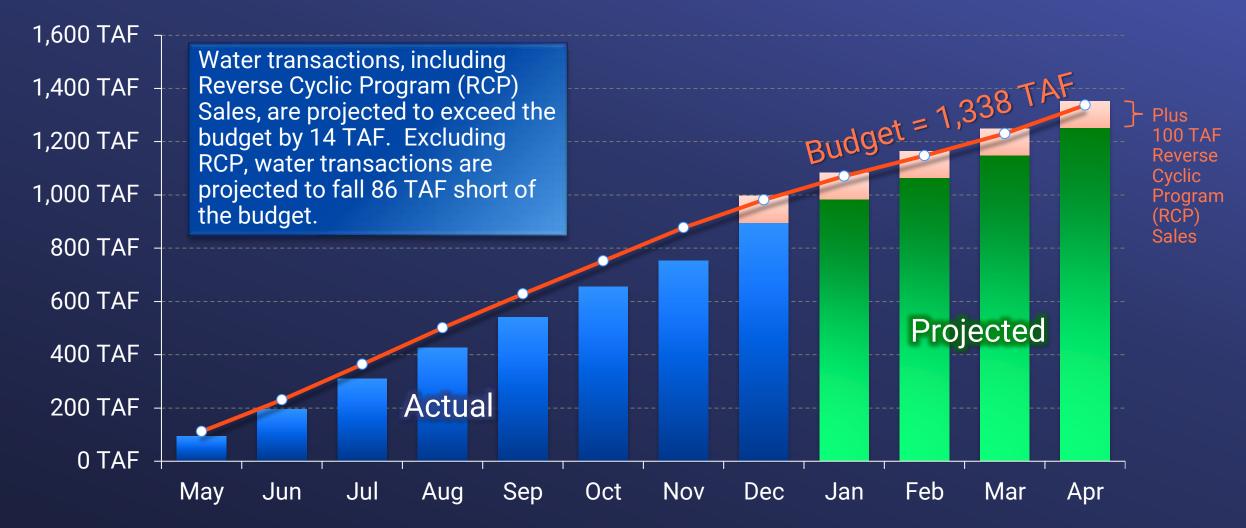

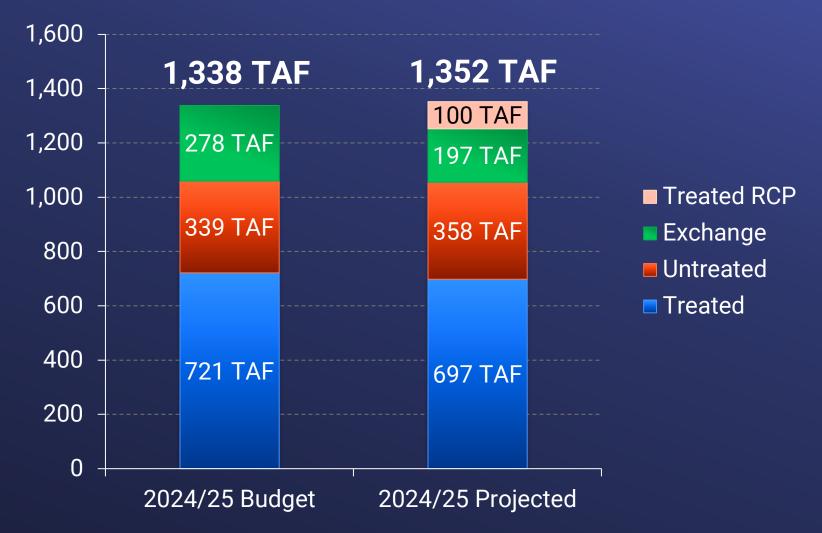
# Cumulative Water Transactions (1) Cash Year 2024/25

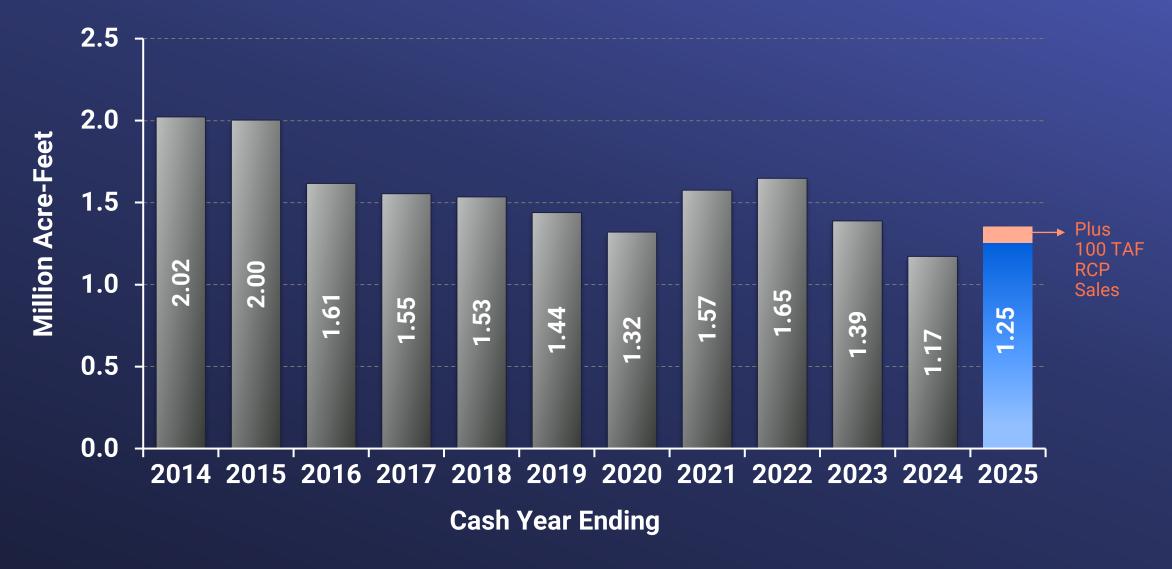
# Water Transactions (1)

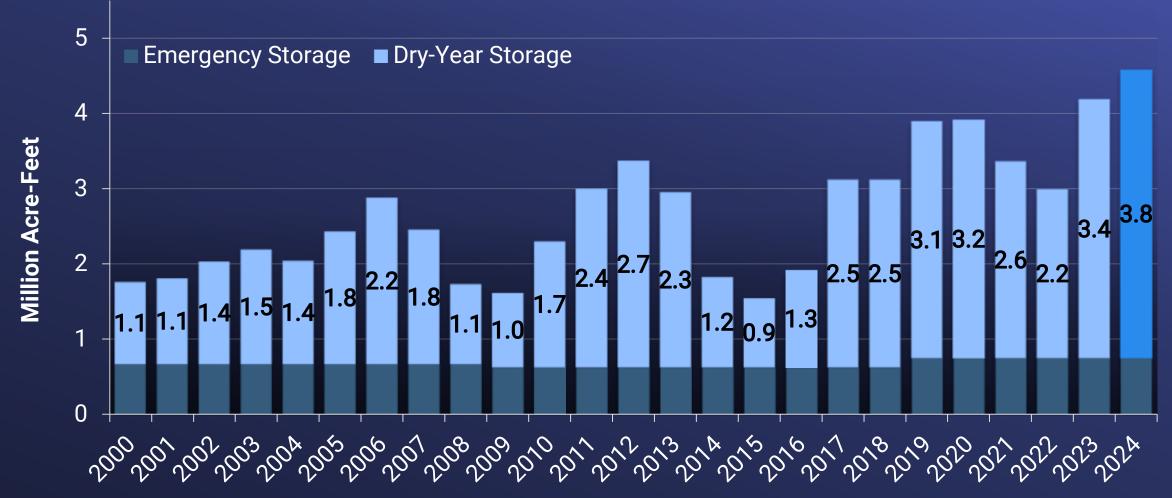
### Historic Water Transactions (1)

June 30, 2025, Unrestricted Reserves are Projected at \$493M (\$367M + \$126M from RCP Sales)

- >\$264M above min reserve
- >\$152M below target reserve

#### **Fiscal Year Ending 2025**

- Cost-saving measures & new revenues initiatives have improved MWD's unrestricted reserves
- Risks remain:
  - 1. Increasing costs to maintain critical & aging infrastructure essential for operational integrity
  - 2. Financial pressure related to organization-wide resource and staffing needs
  - 3. Property Tax impacts from wildfires
  - 4. Uncertainty surrounding grant funds
  - 5. Funding gap and additional financial challenges for the next fiscal year
