Ongoing Tribal Consultation and Engagement

- DWR will continue to pursue consultation meetings with consulting • Tribes throughout the CEQA process
- DWR has hosted tours of the Delta and there are boat tours and other ulletsite visits on hold due to COVID-19 that we hope to conduct in the upcoming year
- DWR and DCA representatives continue to be invited to the monthly ulletTEC meetings to provide technical updates from DCA SEC meetings and provide clarification on topics of interest as requested by the Tribes

Tribal Cultural Resources (TCRs)

Tribal Cultural Resources (TCRs):

- A site, feature, place, cultural landscape, sacred place or object with cultural • value to a "California Native American tribe", that is either on, or eligible for inclusion, in the California Historic Register or a local historic register that the lead agency, at its discretion and supported by substantial evidence, determines should be treated as a Tribal Cultural Resource.
- Public Resources Code section 21074(a) (1-2) ullet



Identification Process for TCRs

- DWR conducting ethnographic research to identify locations in the DCP project area with potential significance
- Consultation with Tribes to identify places with cultural significance to • a California Native American Tribe
- DWR includes the information from consultation for California ulletRegister evaluation of potential TCRs
- DWR will develop a Tribal Cultural Resources **Evaluation Report with Tribal input and review**

Tribal Input

Consultation meetings to discuss resources of cultural value

Provide additional oral or written information about resources of cultural value

Conduct oral history interviews, review transcripts and interview documentation

Process for TCR Identification

- Tribal consultation speaking directly with Tribal representatives about • the places that are important to them and published resources that the Tribe would like to see used;
- Ethnographic review— pulling information from published sources, maps, • and research notes about potential TCRs;
- Interviews with Tribal Scholars and Cultural Experts at the discretion of • the Tribe, following Tribal protocol;
- Where accessible and appropriate, field visits with Tribal representatives • to identify potential TCRs

Tribal Concerns

DWR has heard concerns from Tribes related to:

- Potential impacts to salmon and other fish species
- Potential impacts to other biological (terrestrial) resources
- Potential for impacts to cultural/sensitive/important sites within project footprint, including risk for inadvertent discoveries
- The Tribal value and ecological significance of the Delta region
- Operations, including potential impacts to the Klamath and Trinity Rivers
- Intake site locations
- Requests for access to areas in the Delta
- Requests for Tribal monitoring and compensation

Request for Access

- Access to ancestral lands for traditional practices •
- DWR is reviewing possibility of allowing Tribes access to DWR owned properties and ulletpotentially future restoration areas as appropriate and feasible
- DWR is gathering more information, including Tribal area of interest maps, about ulletlocations in the Delta that Tribes would like to access (such as fishing, gathering, and ceremonial areas)
