
# CAMP4W working definition

"Relative cost burden and elastic ability to access (pay for) service and support member agency efforts to provide affordable supply to their customers."

CAMP4W Working Memo 2 (Aug. 2023)

## Focus of this presentation:

The ability of a customer to pay the water bill in full and on time without jeopardizing the customer's ability to pay for other essential expenses

# California's Human Right to Water Policy

# AB 685 (2012)

"...every human being has the right to safe, clean, affordable, and accessible water adequate for human consumption, cooking, and sanitary purposes."

- Applies to state agencies when revising, adopting, or establishing policies, regulations, or criteria
- Domestic use is generally recognized as 55 gal./person/day (GPCD)

See Title 23, Div. 3, Chap. 2, Arti. 24, §878.1 (b) (1)

# Low-Income Household Water Assistance Program (LIHWAP)


- The federal government never funded household water assistance...until Covid
  LIHWAP
  - Created in the Consolidated Appropriation Act of 2021 to help households during the pandemic
  - American Rescue Plan Act provided additional funding
  - Reimbursements end in March 2024 unless
     Congress authorizes and appropriates additional
     funds

Low-Income Household Water Affordability Program LIHWAP provides emergency assistance, not ongoing household affordability

- Benefit
  - Arrearage: \$2,000 for past-due balances
  - Non-Arrearage: \$200 to \$1,030 based on income
- Program elements
  - One-time benefit
  - Benefit paid only to water system
  - Income less than 60% of state median income
  - Proof of income
  - Proof of identification
  - U.S. Citizenship or qualified citizen

# Affordability

- Percentage of median household income
- Household Affordability Ratio (AR)
  - Ratio of basic water cost to disposable household income for low-income customers
- Hours of labor at minimum wage (HM)



# Common Customer Assistance Programs

- Bill Discounts: Utilities reduce a customer's bill
- Flexible Terms: Utilities adjust repayment terms
- Lifeline Rates: Customers pay a subsidized rate for a fixed amount of water expected to cover basic needs
- Emergency Assistance: Utilities provide short-term or one-time assistance to prevent disconnection or restore disconnection following an unexpected hardship
- **Conservation**: Utilities subsidize or provide water efficiency measures aimed at reducing water use and costs (e.g., fixing leaks, rebates for efficient fixtures and appliances, or in-home water audits)


# Customer Assistance at California's Largest Public Water Utilities

# How can Metropolitan address household affordability?

Policies

Metropolitan supports efforts to provide access to safe and affordable drinking water to all residents

- Support actions that prioritize providing safe and affordable drinking water to disadvantaged communities
- Support actions that meaningfully improve water affordability throughout the region at both the individual and the water system level without burdening existing ratepayers
- Support funding to help water systems provide low-income ratepayer assistance programs

Metropolitan's Legislative Priorities and Principles (2023)

> Scope of Purpose

Metropolitan's Authorized Purpose May "provide, sell, and deliver water at wholesale for municipal and domestic uses and purposes." MWD Act, Sec. 130(c)

- Customers are Member Agencies—not retail customers (households)
- May take on various functions, including conservation to meet its wholesale purpose

May set rates for services that "shall be uniform for like classes of service throughout the district." MWD Act, Sec. 134)

# Metropolitan's Legal Framework

- As a special district, Metropolitan's powers are granted by the Metropolitan Water District Act
  - Single Purpose Entity
- Unlike cities, Metropolitan does not have inherent or police powers
